## **OBJECTIVE:**

For Centralized Empanelment of Service Provider on West Zone for Service Management under the Category "B" Tourist Packages Operated By IRCTC, West Zone.

#### **BACKGROUND:**

IRCTC has established a clear footprint in Tourism industry and emerged as one among the leading tourism companies of India. IRCTC operates a range of tourism products includes Train Tours, Air ticketing, International and Domestic packages, Hotel booking and car rental, Customised and LTC tours, Budget train tours, Special interest tours etc (except Saloon packages). We cater to the requirement of all categories of Budget, whether it is high-end or a budgeted traveller.

#### SCOPE OF WORK: Primary segments of IRCTC on which backend service would be requesting are :-

#### **Trains Charters**

These are an economically priced product giving an all inclusive itinerary including rail travel, road transport, sightseeing, accommodation, meals. It operates on various itineraries covering a number of tourists/pilgrim destinations across the length and breadth of the country.

#### Charter Coach Tour Packages

These are tour packages wherein IRCTC charters coaches on select trains and designs tour itineraries to destinations which have demand from the travelling public. These packages also include confirmed round trip train journeys, hotel accommodation, road transfers, on-board and off-board catering and services of tour escort.

#### **Charter Train Tour Packages**

These are tour packages wherein IRCTC charters an entire train with a varying composition on select routes/circuits and designs tour itineraries to destinations which have demand from the travelling public. These packages also include confirmed round trip train journeys, hotel accommodation, road transfers, on-board and off-board catering and services of tour escort.

#### **Customized Tour Packages**

These are tour packages wherein IRCTC designs tour itineraries/packages to tourist destinations as per the requirements of the customers including LTC packages. These packages are tailor-made and may include confirmed round trip train journeys, hotel accommodation, road transfers, on-board and off-board catering and services of tour escort.

#### Rail Tour/VAT Packages

Tour Packages by earmarking a certain number of berths in various classes of travel in trains giving confirmed train tickets, local transport, accommodation, meals etc.

#### Holiday Packages

Air/Land based packages including surface transport, sightseeing, meals, accommodation etc.

The Service Providers to be Empanelled must have the basic infrastructural facilities and capability to provide one or more of the following services:

- (i) <u>Backend services:</u>
- (a) Provide Hotel / Dormitory accommodation at places of Tourist interest across India in Deluxe / Standard / Budget categories.
- (b) Provide Road vehicles in good condition (A/C, Non-A/C Tempo travelers, Buses, Mini buses, cars etc. not more than 05 years old for Standard Packages and not more than 03 years old for Premium Segments).
- (c) Catering arrangements during the course of the tour to the traveling tourists including train travel, Road or otherwise as per requirements of the tours.
- (ii) <u>Tour guide & escort services:</u> Qualified and Experienced Personnel throughout the tour.
- (iii) <u>Statutory compliances:</u> Central/ Respective state Govt. authorities with regard to obtaining licenses, permits, taxes etc.
- (iv) <u>Branding of Services:</u> The usage of IRCTC logo and name has to be promoted duly ensuring that the brand name and image of IRCTC is not harmed in any manner whatsoever.
- (v) <u>Customer support services</u>: Escalation Matrix, Dedicated E-mails, phone numbers, nomination of staff with mobile numbers or control offices for continuous monitoring, troubleshooting, complaints management etc., during the course of the tours or otherwise.
- (vi) Marketing services:
- (a) IRCTC prefers a clause of minimum occupancy to be guaranteed by the Service Provider in the Tenders/Quotations being invited for specific products.
- (b) In such an event, the Service provider is entitled for travel agent commission as per applicable rates for such bookings.
- (vii) Miscellaneous Services including arrangement of boat rides, PA Systems, Audio Guides etc.
- (viii) Manpower like Trained & Uniformed Housekeeping & Security, with consumables, First Aid, etc.

This empanelment does not qualify for providing backend services for all-inclusive Saloon tour & packages.

- 2. The applicant should submit a complete set of documents in support of specified Financial as well as Technical Eligibility Criteria. However, the competent authority reserves the right to call for clarifications or additional documents in case of non-provision or partial provision of documents.
- 3. Additional Documents submitted to substantiate the credentials of the firm and for meeting the stipulated eligibility criterion should be serially numbered on the top right-hand corner of every page.

The following documents need to be submitted along with application by each firm:

- a. GST Registration number.
- b. PAN card.
- c. Proof or registration/ membership/ affiliation.
- d. Details of experience and proficiency in operating and handling each type of tourism product, depending on category for which application is preferred.
- e. Balance Sheet and P&L accounts for the last 3 financial years, duly certified by a Chartered Accountant mentioning his UDIN number.
- f. Net worth for the last financial year, duly certified by a Chartered Accountant mentioning his UDIN number.
- g. In case of Company, Registration certificate of the company along with Articles of association, address of registration, etc., In case of Partnership firm, registered partnership deed with details of partners, their liabilities and responsibilities.
- h. List of ultimate non-corporate shareholders exercising control in the company certified by a Chartered Accountant.
- i. The address and contact details of all their offices along with the details of the management/ at apex and corresponding level.
- j. Details of tourism staff along with their qualification and experience.
- k. For category B, Standard Earnest Money Deposit is Rs. 10,000/- (Rupees Ten Thousand Only). The Standard Earnest Money Deposit of the empaneled firms/companies shall be retained by IRCTC till the validity of empanelment.
- 1. If an empaneled service provider wants to continue their empanelment service then they have to submit their required document as a fresh empanelment,



# TERMS AND CONDITIONS

#### 1. Terms & Conditions of empanelment:

- a. The company has to do marketing and promotion on behalf of IRCTC of the activities that they undertake.
- b. Use of the IRCTC logo and name has to be purely for promotion of the IRCTC products only and will be such that it does not harm the image and brand name of IRCTC in any way.
- c. Provide the services as mentioned as per the product with its itinerary.
- d. In case of serious complaints regarding standard of service/ behavior, irregularities/negligence on the part of service providers, IRCTC may take action by way of fines, warnings or even termination depending on severity of lapse/complaint, to be decided by GGM (Zonal Head).

The Documents should be submitted to the office of Addl. General Manager Tourism West Zone, Indian Railway Catering and Tourism Corporation Limited (IRCTC), 2nd Floor, Main Line Station Building, Central Railway, CSMT, Mumbai – 400001. The applications shall be opened on the next working day for scrutiny and LOA will be issued within 7 days of submission of the documents. IRCTC will call for any additional documents, if required.

- 2. The **guidelines prevailing at the time of receipt of fresh application.** If empaneled, empanelment shall remain valid, subject to provision of earlier termination, upto the period firms have been empaneled through this process.
- 3. The selection of the Service Provider will be for a period of two years which can be extended by two year, depending on performance and quality of service, and shall be decided by the GGM (Zonal Head), IRCTC.
- 4. This empanelment shall be used by IRCTC Zonal and Regional Offices presently across India for appointment of Service Providers for various Tourism Products.
- 5. The Terms and conditions, Scope of Work for each segment / product will be detailed in the Limited Tender / Quotation document. Limited tender will be called from the operators empaneled as per their category wise eligibility by IRCTC offices concerned.
- 6. IRCTC also reserves the right to call for Financial offer in any format it wishes viz. Lowest offer, Fixed Rate Counter Offer, Revenue Share Percentage, etc.
- 7. If, in response to a Limited Tender / Quotation invited by IRCTC for any of the Tourism Products, no offers are received, IRCTC has the right to appoint a Service Provider outside the panel empaneled through this process or run it Departmentally.
- 8. In case of Customized Tours, the customers may want specific services, for which IRCTC has the right to appoint Service Providers even outside the panel as per requirement of the customers.
- 9. IRCTC reserves the right to appoint more than one Service Provider for a Tour Product / Programme depending upon the nature of services required. This may also mean appointment of multiple Service Providers for similar nature of services.
- 10. During the period of empanelment, if an empaneled Service Provider wishes to withdraw from the empanelment, a written request should be made to Group General Manager, Zonal Office, IRCTC or the concerned office/ officer. IRCTC shall process the applications, on a case to case basis and refund the Standard Earnest Money Deposit of the Service Provider.
- 11. Under circumstances wherein the spirit of competitive offer process is defeated with no / few empaneled operators as a result of delisting / disqualification / debarment / withdrawal from empanelment, IRCTC also reserves the right to invite non-empaneled operators for any specific category / product / segment or otherwise subject to fulfillment of eligibility criteria.
- 12. Wherever it is felt necessary, IRCTC shall have the discretion to rope in the services of hotels/ road transportation companies/ PSAs or GSAs that have agreement with IRCTC directly for tourism services.
- 13. Liability and Indemnity of off-board service provider:- The off-board service provider agrees to defend, indemnify and hold harmless IRCTC and their respective officers, directors, employees and agents (collectively the "Indemnified persons") and its associated companies from and against any and all claims, actions, damages, expenses, costs (including legal costs) and other liabilities actually incurred by the indemnified parties arising as a

result of any negligence, breach of contract or warranty, or any other wrongful act or default on the part of the off board service provider, its employees, agents, representatives or contractors, including prosecution under any legislation.

- 14. **Insurance** The service provider throughout the period of contract shall take insurance for damages, loss & injury which may may be required to operate these tours.
- 15. **Execution of agreement** The successful Bidder shall be required to execute an agreement on non-judicial stamp paper of Rs.500/- at his cost before start of each work order. Till then the letter of award to the service provider shall form the binding agreement between IRCTC and the service provider.
- 16. **Liability of IRCTC** The IRCTC will not be liable for any liability arising under the labour laws or any other law of the land, incurred by the Service provider.
- 17. The back end service provider will indemnify the railway administration /IRCTC for any loss or damage caused to railway property/administration/IRCTC by any act or omission on his part or on the part of his managers/Supervisors/staff.
- 18. **Entitlement of compensation -** In case the Service provider suffers any loss on account of his being restrained by the IRCTC or any competent authority for indulging in illegal activities or any contravention of any law, he shall not be entitled to any compensation whatsoever.
- 19. Notice by Courier / Registered AD Upon the receipt of any notice, order, direction or any other communication from any competent authority (including notices, affecting the rates, taxes or other outgoings) in respect of provision of off board services, payable in whole or in part by one Party hereto, the other Party shall immediately deliver a copy of the necessary document, to that Party.
- 20. **Notice to the Service provider** Any notice to be served on service providers shall be deemed to be sufficiently served if delivered at or sent by registered post/courier addressed to the service provider at their registered office or last known place of business. Any notice to be served by the Service provider on IRCTC shall be deemed to be sufficiently served if, left at the office/sent by registered post/courier addressed to the Addl. General Manager Tourism, Indian Railway Catering and Tourism Corporation West Zone Mumbai.
- 21. **Notices on behalf of IRCTC** Subject to as otherwise provided in the empanelment, all notices to be given on behalf of IRCTC and all other actions to be taken by IRCTC may be given or taken on behalf of IRCTC by the Group General Manager/Addl. General Manager Tourism West Zone Mumbai or any other officer for the time being entrusted with such functions, duties and powers by IRCTC.
- 22. **Dealing with Service provider Only** IRCTC will enter into an agreement only with the service provider who will be responsible for fulfillment of all service provider conditions with IRCTC. The IRCTC shall not enter into any agreement or deal in any manner with any of the sub-service providers.
- 23. **Consequence to the death / severance of any partner/s (in case of partnership firm) -** If the service provider is a partnership firm and in case there is permissible clause in the constitution of the firm that the firm shall not be dissolved by reason of the death of one partner or the severance of any partner from the business of the firm and in case the performance of the Service provider is entirely satisfactory according to the assessment of the IRCTC then in such an event the IRCTC at its discretion may allow the Service provider to continue under the agreement.
- 24. **Notice for termination** In case of any event of default occurred, it shall be lawful for the IRCTC any time thereafter to terminate the Service provider agreement and forfeit the Standard Earnest Money Deposit. However, IRCTC shall give the Service provider seven (7) days prior notice in writing to remedy or make good such breach and in spite of such notice the service provider having failed to remedy the breach. The Licensee shall also be debarred from participating in the future projects of IRCTC for a period of one year.
- 25. Selection of L 1 Letter of award to manage the backend services of tours will be awarded to the empaneled applicant quoting the lowest amount. IRCTC may negotiate with the successful back-end service provider for reduction in the quote in order to ensure a minimum IRCTC margin for the operational feasibility of the tour on a case-to-case basis.

26. **Force Majeure:** IRCTC shall not be liable to the service provider in respect of any breach of the terms and conditions due to any event or circumstances beyond its reasonable control.

### 27. Arbitration and Conciliation:

- a. In the event of any dispute or difference between parties hereto as to construction or operation of this contract or the respective right and liability of the parties on any matter in question, with reference to the contract, the Parties agree to use their best efforts to attempt to resolve all disputes in prompt, equitable and good faith. In the event the Parties are unable to do so, such parties may submit demand in writing for reference of dispute to arbitration as prescribed herein.
- b. The parties hereto further agree to waive off the applicability of sub-section 12 (5) of Arbitration and Conciliation (Amendment) Act 2015 and will submit demand in writing that the dispute/ differences be referred to arbitration along with format annexed hereto as Format- 5. The demand for arbitration shall specify the matters which are in question, or subject of dispute or differences as also the amount of claim item wise.
- c. Only such disputes or differences, in respect of which the demand has been made, together with counter claim of setoff given by IRCTC shall be referred to arbitration and other matters shall not be included in the reference.
- d. In the event of demand made as mentioned herein above, such dispute or difference arising under any of these conditions or in connection with this contract (except as to any matters the decision of which is specially provided by these or the special conditions) shall be referred to Sole Arbitrator from the panel of Arbitrators appointed by Chairman and Managing Director of IRCTC. The award of arbitrator shall be final and binding on the parties to this contract. The venue of Arbitration shall be at Mumbai. The fees and expenses of the Arbitration Tribunal and all other expenses of the Arbitration shall be borne jointly by the Parties in equal proportion subject to determination by the Arbitration tribunal.
- 28. Backend service providers will ensure that the services offered to the tourists of the IRCTC packages are managed by well-trained & courteous staff. Backend service providers shall also be required to ensure that the instructions relating to hygiene, quality parameters for kitchen and the food served, FSSAI, food handling, cleanliness, packaging, etc. are followed. The contractor will follow all prevailing labour laws and regulations. The agreement between IRCTC and the backend service provider shall not create any contractual relationship between the agency's own staff or its sub-contractor's staff and IRCTC. IRCTC shall not be the "principal employer" in case of employees/staff engaged by the backend service provider. If any proceedings are instituted against IRCTC regarding non compliance of any labour law, then the backend service provider would be liable to make good all the loss occurring to IRCTC as a result of those proceedings including the cost of defending the proceedings.
- 29. All disputes shall be subject to the jurisdiction of courts at Mumbai.
- 30. IRCTC reserves the right to terminate the EOI process at any stage and will not be responsible for any loss or damages which the applicant may incur in the process. The application can be rejected without assigning any reason.
