- 3) To pay Annual License fee of **Rs.14,000/- + GST @ 18% i.e.Rs.2,520/- =Rs.16,520/- (Sixteen Thousand Five Hundred Twenty Only)** and all other applicable taxes as per tender conditions. Payments to be made through NEFT/RTGS to IRCTC/**East Zone** account. The accounts details are as under:

- 4) To submit preliminary plans, specifications and tentative time schedule for commissioning of above unit for approval of IRCTC with Zonal/Regional office under **East Zone** within Thirty (30) days from the date of remittance of security deposit.
- 5) If Railway/IRCTC suggests changes in the General Arrangement of Drawing (GAD), the new GAD has to be submitted within twelve (12) days after advice by zonal office.
- 6) To pay advance annual license fee and GST thereon along with land license fee with applicable taxes and other taxes if any to IRCTC in advance.
- 7) To pay License fee as mentioned in the point no. 3 above, GST, thereon and other tax if any to IRCTC. The quoted annual License Fee for 1st year shall be paid at the time of handing over of site but is applicable from time of commissioning of Retiring room & dormitories or **within 120 days from the date of handing over of site whichever is earlier.**
- 8) To take over the site within time frame specified by IRCTC Zonal / Regional office after issuance of letter of approval of GAD. At the same time you are also required to deposit Annual License Fee (plus all applicable taxes) agreed upon.
- 9) On successful completion of one year, the license fee shall be increased @ 5% every year compounded annually till the expiry of license. At the beginning of second year the deposited license fee shall be 5% in addition to the license fee quoted for first year or 15% of the annual sales turnover of first year, whichever is higher.
- 10) The agreement is to be executed within 30 days from the date of commissioning of unit on non judicial stamp paper of Rs.100/- as per tender conditions.
- 11) All terms and conditions of the tender document shall remain unchanged and form an integral part of this letter of award.
- 12) This letter of award is subject to the final outcome of any litigation, filed before any Court of Competent Jurisdiction.
- 13) The Service Provider shall comply with the directions/protocol issued by Govt. of India/IRCTC from time to time.

In the event of failure to adhere to the abovementioned conditions the same shall be treated as an event of default and action shall be initiated as per terms and conditions of the License.
