With reference to your Technical & Financial Bids opened on 06.03.2025 and 25.04.2025 respectively and e-auction conducted on 01.05.2025 for the above project, it has been decided to award license to set up, operate and manage **Food Plaza** at **Vishakhapatnam** Railway Station for a period of **(09) Nine** years from the date of commissioning of the Unit to **M/s Sri Sai Enterprises** on the following conditions, in addition to terms & conditions enshrined in tender document. You are required:

- 2) To remit an amount of **Rs.1,41,38,490/- (One Crore Forty One Lakh Thirty Eight Thousand Four Hundred Ninety Only)** towards **Security Deposit** in favour of IRCTC Ltd. payable at **IRCTC/SCZ** through NEFT/RTGS or through unconditional and irrevocable Bank Guarantee (BG) OR Fixed Deposit (FD) (issued by any Nationalized Bank or Scheduled Commercial Bank with validity upto 180 days beyond the completion of the tenure of the contract as per enclosed Annexure-C2 within 07 days from issue of this letter i.e. **on or before 14.05.2025**, A/c details are as under:

- 4) To submit preliminary plans, specifications and tentative time schedule for commissioning of above unit for approval of IRCTC with Zonal/Regional office under **South Central Zone** within fifteen (15) days from the date of remittance of security deposit.
- 5) If Railway/IRCTC suggests any changes in the General Arrangement of Drawing (GAD), the revised GAD has to be submitted within fifteen (15) days after advice by Zonal office.
- 6) To take over the site within the time frame specified by IRCTC Zonal / Regional office after issuance of letter of approval of GAD. At the same time **M/s Sri Sai Enterprises** is also required to deposit 50% of the License Fee (plus all applicable taxes) agreed upon.
- 7) To execute the agreement within 30 days from the date of commissioning of the unit on non-judicial stamp paper of Rs.100/- as per tender conditions with **South Central Zone** office.
- 8) All terms and conditions of the tender document shall form an integral part of this letter of award.
- 9) This letter of award is subject to the final outcome of any litigation, filed before any Court of Competent jurisdiction.
- 10) The Service Provider shall comply with the directions/protocol issued by Govt. of India/IRCTC from time to time.

Any failure to adhere to the abovementioned instructions shall be treated as event of default and action shall be initiated as per terms and conditions of the License.
