

Vide OM dated 11.04.2023, DoE (MoF) had issued guidelines to support MSMEs by providing relief in all contracts for procurement of goods and services by release of 95% of forfeited security deposits, forfeited EMDs, Risk purchase recoveries, deducted LD and revocation of debarment for non-performance in the contracts, for the period where original delivery period was between 19.02.2020 and 31.03.2022 and tender opened between the same period for EMD.

Now, Vide OM under reference (ii) above, DoE has extended the ambit of relief for MSMEs from procurement of goods and services to all procurements. The date for submission of claims has also been extended upto 31.07.23 and eligible MSME can be registered for any category instead of earlier provision of registration for any category of goods and services. Copies of the above references are enclosed for reference and implementation for relief to MSMEs.

Vide OM under reference (i) above, DoE (MoF), had issued guidelines to support MSMEs vide their OM No F.1/1/2023-PPD dated 11.04.2023 by **providing relief in all contracts for procurement of goods and services**, by release of 95 % of forfeited security Deposits, forfeited EMDs, Risk purchase recoveries, deducted LD (Liquidated Damages) and revocation of debarment for non-performance in the contracts, for the period where original delivery period was between 19-02-2020 and 31-03-2022 (for SD, LD and RP recovery) and tender opened between the same period for EMD.

Now, vide OM under reference (ii) above, DoE has extended the ambit of relief for MSMEs from procurement of goods and services to **all procurements**. Further, the date for submission of claims has also been extended **upto 31.07.2023** and eligible MSME can be registered for **any category** instead of earlier provision of registration for any category of goods and services.

CRIS shall make the system ready accordingly. Necessary action may be taken in this regard.


Subject: Vivad Se Vishwas I - Relief for MSMEs.
