2. Possessing a degree in any discipline/diploma in Engineering.
3. Proficiency of work in MS-Office/Excel/Access.
4. Experience of minimum two (02) years in Vigilance department/Vigilance wing of Central Government Organisations (Ministries/Departments/Autonomous Bodies/PSUs).
