<u>Scale of pay: -</u> As per the DPE guidelines, Government employees in CDA scale on their selection for deputation would be eligible to draw their pay, perks and allowance of their parent cadre only along with prescribed Deputation, Uniform, Fitment allowance & Lease/HRA at prescribed rate etc. If opted for, they will be eligible for IRCTC indoor medical facilities with reimbursement of outdoor medical expenses as per extant rules of IRCTC.

Rs. 9300-34800 GP 4200 ( $6^{th}$  CPC)/Level-6 ( $7^{TH}$  CPC) with more than three years in the GP/level (Eligibility for E0 level)-OR- Rs. 30,000-1,20,000 IDA Scale, E0 or its equivalent
