- 2. Successful bidder shall have to deposit a performance security deposit amounting **05% (Five Percent)** of the total contract value to IRCTC, within **15-days** from date of issue of Letter of Acceptance (LOA)/Contract. The delay in submission of PSD will a ttract a penal interest of 18% per annum shall be charged for the day beyond 15 day s from the date of LOA. - 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
