### 2. Buyer Added Bid Specific ATC

1. EMD should be submitted in the form of DD issued from any nationalized or Scheduled Commercial Bank in favour of Indian Railway Catering & Tourism Corporation Ltd payable at New Delhi or through NEFT/RTGS in account no 00030350003882. Further details as per Clause 2 of Section-II (Instructions to bidders) of the attached Tender Document.

2. Successful bidder shall have to deposit a performance security deposit amounting **05% (Five Percent)** of the total contract value to IRCTC, within **15-days** from date of issue of Letter of Acceptance (LOA)/Contract. The delay in submission of PSD will attract a penal interest of 18% per annum shall be charged for the day beyond 15 days from the date of LOA. Further details as per Clause 7 of Section-II (Instructions to bidders) of the attached Tender Document.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
