

In case the Successful Bidder withdraws the offer before issue of LOA, the EMD submitted by the bidder shall be forfeited along with the debarment for participating in any future projects of Authority for a period up to 1 year.</p> <p>iii. In case the Successful Bidder does not accept the LOA as per the schedule advised by IRCTC, the award offer may be withdrawn and EMD shall be forfeited along with the debarment for participating in any future projects of Authority for a period up to 1 years.</p> <p>iv.
